

## **Pecuniary Legacy (gift of cash)**

I give £[....] (SUM IN WORDS pounds) to Rehabilitation Services Trust for Oxfordshire Reemployment Limited (trading as "Restore") (Registered Charity No. 274222) of Manzil Way, Cowley Road, Oxford, OX4 1YH for its general charitable purposes, and I direct that the receipt of the treasurer or duly authorised officer shall be sufficient discharge to my Executors.

A pecuniary legacy is a sum of cash left under your Will to a named beneficiary such as Restore. The value of the gift is completely at your discretion.

### Example:

I give £100 (one hundred pounds) to Rehabilitation Services Trust for Oxfordshire Reemployment Limited (trading as "Restore") (Registered Charity No. 274222) of Manzil Way, Cowley Road, Oxford, OX4 1YH for its general charitable purposes. I direct that the receipt of the treasurer or duly authorised officer shall be sufficient discharge to my Executors.

# Specific Legacy (gift of an item)

I give my [Name item] to Rehabilitation Services Trust for Oxfordshire Re-employment Limited (trading as "Restore") (Registered Charity No. 274222) of Manzil Way, Cowley Road, Oxford, OX4 1YH for its general charitable purposes, and I direct that the receipt of the treasurer or duly authorised officer shall be sufficient discharge to my executors

A specific legacy may include gifting things you own at the date you make your Will such as personal possessions or shares. It is important to be aware that if you no longer have the item at the date of your death Restore will not benefit from such item.

#### Example:

I give my coin collection to Rehabilitation Services Trust for Oxfordshire Re-employment Limited (trading as "Restore") (Registered Charity No. 274222) of Manzil Way, Cowley Road, Oxford, OX4 1YH for its general charitable purposes, and I direct that the receipt of the treasurer or duly authorised officer shall be sufficient discharge to my Executors.

## **Residuary Gift**

I give a [..]% share of my residuary estate to Rehabilitation Services Trust for Oxfordshire Reemployment Limited (trading as "Restore") (Registered Charity No. 274222) of Manzil Way, Cowley Road, Oxford, OX4 1YH for its general charitable purposes, and I direct that the receipt of the treasurer or duly authorised officer shall be sufficient discharge to my Executors.











The residue is essentially everything that is left in your estate once all the liabilities, taxes and pecuniary and specific legacies have been met. You can gift the residue to one person or charity, or you can divide the residue between multiple people or causes.

# Example

I give a 25% share of my residuary estate to Rehabilitation Services Trust for Oxfordshire Reemployment Limited (trading as "Restore") (Registered Charity No. 274222) of Manzil Way, Cowley Road, Oxford, OX4 1YH for its general charitable purposes, and I direct that the receipt of the treasurer or duly authorised officer shall be sufficient discharge to my Executors.
